DEFINITIONS

Births: Number of live births to women residing in the specified area.

Medicaid: Medicaid/ Family Health Plus as the primary payor or a response of Yes to the question "If Medicaid is not the primary payor, is it a secondary payor for this delivery?"

Early Prenatal Care: A response of Yes to the question "Did mother receive prenatal care?" and having a Date of First Prenatal Visit within 90 days of the Date of Last Menses.

Birthweight: LBW: Birthweight lower than 2500 grams.

Smoking During Pregnancy: A response of Yes to the question "Smoking Before or During Pregnancy?" and a response > 0 to the question "Number of packs or cigarettes smoked per day, during the first three months of pregnancy". Mother's response is used.

Breastfeeding: The response to the question "How is infant being fed?" is either 'Breast Milk Alone' or 'Both Breast Milk and Formula'.

Unintended Pregnancy: The response to "Thinking back to just before you were pregnant, how did you feel about becoming pregnant?" is either 'You wanted to be pregnant later' or 'You didn't want to be pregnant then or at any time in the future'.

Birth to Teens: The mother's age is calculated to be < 18 based on Mother's Date of Birth and Infant Date of Birth (of 1^{st} born, if multiple delivery).

Alcohol Use During Pregnancy: A response of Yes to the question "Alcohol Consumed During This Pregnancy?".

Substance Abuse During Pregnancy: A response of Yes to the question "Illegal Drugs Used During This Pregnancy?".

HIV Pretest Counseling Documented: This data is no longer collected in the birth certificate registration process.
